

506 REVENUE FROM INVESTMENTS

Within the constraints of federal and provincial legislation, the Secretary-Treasurer shall secure the most attractive interest rates for investment of school district funds.

Determination of how surplus funds are to be allocated, excepting only those surplus funds that have their usage pre-determined by the School Act or other governmental order, shall occur during the approval of the annual budget.
